**Additional information:**

1. The Consumer and the Customer-Consumer have the right to withdraw from a distance contract (e.g. via the Internet) within 14 days from concluding the contract, without giving any reason.
  2. The Consumer or the Customer-Consumer loses the right to withdraw from the Online Course Order before the expiry of the 14-day withdrawal period, if, after the Seller informs the Consumer or the Customer-Consumer about the loss of the right of withdrawal and consent to the execution of the Online Course before the expiry of the 14-day (or a longer, stipulated in the law of another country) deadline to withdraw from the contract, the Seller will perform the Online Course - in full.
3. The definitions used in the form have the following meanings:
- a) **Consumer** – an adult natural person with full legal capacity, making a purchase from the Seller not related directly to its business or professional activity.
  - b) **Customer** - an adult natural person with legal capacity, a legal person or an organizational unit without legal personality, but having legal capacity, making a purchase from the Seller directly related to its business or professional activity.
  - c) **Customer-Consumer** - an adult natural person making a purchase from the Seller directly related to its business activity, when the purchase is not of a professional nature for that person, resulting in particular from the subject of business activity, made available on the basis of the provisions on the Polish Central Registration and Information on Business Economic or equivalent register in other country
